Youth work supports a young person's personal, social and educational development. You will manage the gym during sessions and supervise young people using a range of equipment. You will also establish positive relationships with young people; challenging, supporting and encouraging them as they develop.

Main Responsibilities:

- To work directly with children and young people aged 8-19 years old (25 with a disability) to lead and deliver safe and structured gym and fitness sessions within BLGC.
- To confidently manage the fitness suite during sessions, including conducting gym inductions and supervising children and young people using the range of fitness suite equipment safely.
- To confidently manage and establish positive relationships with groups of children and young people.
- To work flexibly to ensure the needs of young people are met, including young people and those with disabilities or additional needs.
- To ensure that young people maintain a high standard of behaviour and discipline during sessions.
- Effectively communicate at all levels.
- Be able to work on own initiative including being flexible to meet the needs of children and young people.
