- Encourage positive behaviour and challenge concerning behaviour.

- Act as a mentor and guide for youth support workers and young leaders.
- Promote a positive image of BLGC and be a role model through your work with young people.

- Ensure any volunteer that you encounter is made to feel an integral part of the BLGC Family.
- Participate in continued professional development.
